

**CANADIAN MODEL & TALENT CONVENTION, CMTC INC.
REGISTRATION TERMS & CONDITIONS**

Payments may be made by Certified Cheque, Money Order, Bank Draft, Visa or MasterCard only. Personal or business cheques that are not certified will not be accepted. No receipts will be issued. Purchases made convention weekend must be paid by cash only. Registration Payment Deadline is March 1, 2010. A \$50 fee will be charged to all late registrations and late balances received after March 1, 2010. Date on postmark / courier will determine price point on Registration Base Fee. Registration Base Fee includes four (4) days of convention, three (3) competitions of the Contestant's choice, access to all Seminars and Workshops, Portfolio Review, Talent Headshot & Resume Review, Theme Party Dances, trophies for top Contestants, personalized Certificate of Participation and the Contestant's photo in the CMTC Program Book provided the photo is received by CMTC before March 1, 2010. CMTC can not guarantee that photos received after March 1, 2010 will appear in the CMTC Program Book. All Contestants registered for CMTC must purchase a mandatory Awards Banquet Dinner Ticket. Awards Banquet Ticket includes admittance to the Cocktail Reception, Awards Banquet Dinner, Awards Ceremony and Dance. Due to limited space, **only two Visitor Awards Banquet Ticket per Contestant available until March 1st, 2010.** If Contestants are interested in purchasing additional Awards Banquet Tickets, please contact the CMTC Office to be placed on the Awards Banquet Ticket waiting list. Visitors appearing on the waiting list will have first option to purchase any available tickets. Awards Banquet Tickets purchased after April 1st will not be guaranteed seating within their School/Agency group's designated area. Seating in the main ballroom is available on a first come, first served basis. Once the main ballroom has reached capacity, limited seating will be available in an overflow room with a large screen for viewing the Awards Ceremony.

Participants, Attendees &/or Contestants are responsible for booking their own hotel accommodations directly through the Hilton Toronto Airport Hotel - 1 866 565 4555. Ask for the CMTC VIP Convention Rate, rooms at this special discounted rate are limited. To ensure the convention rates are kept at an affordable price all Models/Talent must book accommodations at the Hilton Toronto Airport Hotel. Contestants not booking their hotel through the Hilton Toronto Airport Hotel must pay a \$50.00 Convention Hotel Charge to CMTC.

The terms "Participant", "Attendee" &/or "Contestant" shall include, where applicable, the Parent or Legal Guardian, if such Participant is a minor under the age of 18. The Parent or Legal Guardian is responsible for compliance of all terms contained in the Agreements including payment.

I/We understand that a special place is being reserved for me/us and I/we agree to the following terms and conditions:

- I/We understand that the \$195.00 down payment is non-refundable and non-transferable.
- **I/We understand that this registration agreement is FINAL and cancellations will not be accepted. All convention fee payments are payable when due and are non-refundable. I/We am/are responsible for the full balance owing regardless of my/our ability to attend CMTC 2010. Furthermore, CMTC reserves the right to collect any balances due under the terms of this Agreement and the Registration Agreement. Under extenuating circumstances, and at the discretion of CMTC only, a credit may be given to the fees for a future CMTC Convention except for the non-refundable and non-transferable down payment of \$195.00.**
- I/We understand that if I/we am/are disqualified from CMTC, or am unable to attend for any reason, that I/we will not be entitled to any refund of fees paid to CMTC.
- I/We understand that as a Participant, Attendee &/or Contestant of CMTC, I/we am fully responsible for: (a) any and all additional costs or expenses incurred at the convention site; (b) any and all cost or expenses incurred with any photographers; and (c) any and all costs or expenses incurred in travelling to and from the convention site.
- I/We understand that no receipts will be issued by CMTC and that it is my/our responsibility to retain a copy of the CMTC Contestant Registration Agreement, Payment Agreement and Release Agreement.

I/We agree to the above terms and conditions which are in accordance with the Registration Agreement Contract and the Rules & Regulations of CMTC.

Participant, Attendee, &/or Contestant hereby grants CMTC the right to publish or utilize Participant's, Attendee's &/or Contestant's photographs, video, film, visuals or sound reproductions for publicity or promotional purposes.

AND IT'S AGENTS, REPRESENTATIVES, DIRECTORS, OFFICERS, EMPLOYEES, SUCCESSORS AND ASSIGNS ("RELEASEES") FROM ANY AND ALL CLAIMS, DEMANDS, EXPENSES, CAUSES OF ACTIONS, DAMAGES AND LOSSES RESULTING FROM, ARISING OUT OF, IN CONNECTION WITH OR RELATED TO, MY/OUR ATTENDANCE/PARTICIPATION AT CMTC, INCLUDING WITHOUT LIMITATION, DAMAGES ARISING FROM, OR IN CONNECTION WITH, PERSONAL INJURY OR DEATH OR TEMPORARY OR PERMANENT DISABILITY OR DAMAGE TO PROPERTY; HOWEVER CAUSED BY ANY ACT, OMISSION OR NEGLIGENCE OF THE RELEASEES OR ANY OTHER PARTICIPANT, ATTENDEE &/OR CONTESTANT AT CMTC.

Neither CMTC nor the convention site is required to, and may not, maintain liability and/or casualty insurance covering the convention, it's Participants, Attendees &/or Contestants. The Participants, Attendees &/or Contestants shall attend CMTC at his/her sole risk.
